For each PAC listed, the index provides the full name of the PAC, its city, state, FEC identification number and, if not identifiable from the full name, its connected, sponsoring or affiliated organization.

The index is helpful in identifying PACs that are not readily identified in their reports and statements on file with the FEC.

## Looking for Back Issues of the Record?

Whether you're researching a range of campaign finance issues or looking for specific information from 1996, 1997, 1998 and 1999, look to the FEC's official web site to find issues of the *Record*. The web site—<http://www.fec.gov>—includes issues dating from January 1996 to the present. Go to the web site and click on "Campaign Finance Law Resources" to see back issues. Also click on "What's New" to find the most current issue of the *Record*.

A hypertext version of the 1999 *Record* index will soon be available. It will feature alphabetical links that can be used to search for information by topic. Each topic listing will be linked to the first page of the *Record* issue in which that topic was discussed. Clicking on a topic link will download the selected newsletter issue to your computer. The 1996, 1997 and 1998 *Record* indexes are also available in a hypertext version.

For each of the issues available at the web site, you will need Adobe® Acrobat Reader software to view or print the publication. The FEC's web site has a link that will take you to Adobe's web site, where you can download the latest version of the software for free.
