Request for Advisory Opinion

The Helms for Senate Committee (1990 General Election) ended the 1990 general election with a campaign debt of approximately \$1,000,000.

The Committee relies heavily on small contributions it receives through direct mail fundraising, its primary way of raising funds.

The Committee will be soliciting over 120,000 previous supporters through the mail to seeking contributions to pay its debt.

Helms for Senate Committee estimates it will need a <u>minimum</u> of 30,000 to 40,000 donations to eliminate its debt (including the costs of fundraising).

In mailings since the November General Election, Helms for Senate Committee has asked donors to designate on their checks that donations are for Senator Helms's Campaign debt.

Approximately 50% of the supporters have done so.

When a supporter does not designate his post-election donation is for the 1990 debt, usually he (or she) simply returns a contribution check made out to Helms for Senate Committee -- without writing "debt" on the check.

Helms for Senate Committee has written all their donors who did not specifically designate in writing that their post election contribution was for the debt, sending them a redesignation form to sign and return. Page two

However, if a substantial number of supporters responding to future appeals simply make checks to Helms for Senate Committee and do not clearly designate "debt" on their checks, Helms for Senate Committee is faced with a heavy and expensive administrative burden of recontacting tens of thousands of donors to seek redesignations.

Proposal

Helms for Senate Committee will state clearly in all solicitations: 1) That the use of donations will be to pay 1990 general election debts; 2) repeating the same on the contribution slips; and 3) including an additional line on the disclaimer stating funds will be used for 1990 debt elimination. Further, 4) the Committee will solicit funds for no purpose other than to pay 1990 debts (including the cost of fundraising).

We request that the Commission allow Helms for Senate Committee to meet the designation requirements by taking these four steps.

Helms for Senate Committee asks the Commission to concur that if a supporter makes a contribution after receiving solicitations wherein the solicitations, the contribution slips, and the disclaimers all state the purpose of the contribution is to pay debts, that the donor's intention is to contribute to pay debts even if he (or she) does not so note on his (or her) check or by signing a contribution slip or redesignation form.

Further, the Committee is willing to state to the Commission its intention is to raise funds to pay its 1990 debt, wind down its activities and then it will close down. No funds from the 1990 Helms for Senate Committee, will be carried forward to Senator Helms's 1996 Reelection Committee, should he decide to run. The only purpose Helms for Senate Committee has to raise funds is to pay campaign debts.

This would relieve the Helms for Senate Committee of the excessive administrative burden and expense of seeking written redesignations from thousands of donors.

We would welcome the opportunity to meet with the Commission or staff to discuss this request.

And we would welcome any other solution the Commission or staff might suggest.
