AREA 3 E

Section 5 of the Charter of the Patriot Federal Credit Union is hereby amended to read as follows:

- 1. Civilian employees and military personnel of the U. S. Government who work at or are stationed at Letterkenny Army Depot, Chambersburg, Pennsylvania; employees of non-appropriated fund activities who work at the Letterkenny Army Depot; employees of the branch bank who work at the Letterkenny Army Depot;**
- 2. Civilian employees and military personnel of the U. S. Government who work at or are stationed at Fort Ritchie, Maryland;**
- 3. Members of the U. S. Armed Forces, active or retired, of their dependents or dependent survivors who are eligible by law or regulations to receive and are receiving benefits or services from the above military installations;**
- 4. Contractors and employees of contractors who work regularly at the above military installations under contract with the U. S. Government;**
- 5. Military personnel of the U. S. Government who are stationed at Camp David, Maryland;**
- 6. Military personnel of the U. S. Government assigned to the ROTC unit at Gettysburg College, Gettysburg, Pennsylvania;**
- 7. Advanced Course cadets of the Army ROTC program and military personnel stationed at Shippensburg, Pennsylvania;**
- 8. Employees of the Federal Government, State of Pennsylvania, Franklin County, or political sub-division in Franklin County, who work in Franklin County, Pennsylvania, and who do not have credit union service available through another employee-type credit union;**
