Dear Mr. Marinelli:

On behalf of the Executive Committee of the US Oncology National Policy Board ("USON NPB"), we are writing to support and associate ourselves with the Advisory Opinion request dated June 8, 2004, submitted by USON. In that request, USON seeks the opinion of the Federal Election Commission (the "Commission") that it is affiliated with the physician practices with which it has entered service agreements. We support that request and the outcome that USON is seeking.
