I have just become aware of the request indicated above (2022-14), and write this to express my concerns and objections in the strongest possible terms.

Unsolicited emails ("spam"), as well as other forms of unsolicited communications via telephone calls and text messages, represent an escalating assault on an individual citizen's ability to enjoy peace and quiet at home, free of interruption by parties acting for their own interests.

Others more qualified than I have written persuasively on the corrupting influence of money on the public political process. Unlimited access to the email in-boxes of millions of persons is an asset of significant monetary value, allowing participants in the business of promotion to leverage greatly their financial resources.

While they may have a legal right to "freedom of speech", there is no guarantee of audience stated in the constitution. And the right of the individual to choose NOT to receive their communications should be protected even more vigorously—as in many other cases in which the government exists to protect the individual and the powerless from the intrusions of the well-funded.

I urge you to reject any attempt of technology to further intrude on the right of individuals to be protected from unsolicited communications, especially those dealing with political advertisement.

By doing this, Google makes a unilateral decision to cripple its own email management features, thereby overriding the stated preferences of its users and substituting the desires of specific advertisers



In my opinion as a professional who works in the email space, I find this bill ridiculous and an attempt to address the wrong problem with political emails. frankly, more political email belongs in the spam folder:

- It is rare for the recipient to have opted into the sender's lists, or to have indicated any desire to receive communications from them at all
- Subject lines and content are often sensationalist
- The Sender ID is often not connected directly to the actual organization sending the email (and using that email as a vehicle for raising funds)

These issues are even more problematic on SMS, which adds the indignity of the recipient being forced to PAY for the spam they're receiving.

Instead of attempting to inflict even more spam on inboxes, how about simply expanding CAN-SPAM to include political emails?
